# UNIVERSITY OF MAINE SYSTEM STUDENT FEES

## OVERVIEW

The procedures for establishing student fees throughout the University of Maine System are as follows:

The **BOARD OF TRUSTEES** will establish those fees that are analogous to tuition, i.e., those that must be paid by all students as a condition of attendance. In addition, Student Activity Fees turned over to student governments are set by the Board of Trustees, upon the recommendation of the university administration, after approval by referendum of the students affected. Board approved fees include the Student Activity Fee, the Communications Fee, the Unified Fee, and the Recreation Fee.

The **CHANCELLOR** will establish those fees impacting services and operations within the System. These include maximum levels for financial service fees (non-negotiable check fees, installment or collection charges) and fees principally affecting prospective students, such as application and matriculation fees.

The **UNIVERSITY PRESIDENTS** are responsible to the maximum extent possible for establishing most university-specific fees, which include:

- all course fees
- all deposits
- all fees for optional university services and activities

Fee changes planned for the fall semester should ordinarily be adopted no later than May; those to become effective in the spring semester should be adopted by November 15. Universities should establish procedures for timely review of and comment on fee changes. The Chancellor should be informed in advance of the formal adoption of any fee changes.

Adjustments to Student Activity Fees will be considered by the Board at its May meeting in order to allow sufficient time for student governments to conduct spring referendums on any changes recommended to the fees.
