#### 5. BACKGROUND:

The Chancellor Search Committee, appointed by the Chair and charged by the Board, has conducted a national search for the chancellor to succeed Chancellor James Page, who will be retiring June 30, 2019. The Search Committee has completed its work and reported to the Chair.

Chair Erwin is pleased to recommend that Dannel P. Malloy be appointed as Chancellor, effective July 1, 2019, for a three-year term.

Dannel Malloy has a long record of public service. He served as the 88<sup>th</sup> Governor of Connecticut from 2011 to 2019. Before becoming governor, he served as Mayor of the City of Stamford, Connecticut from 1995 to 2009. He also served as Assistant District Attorney in Brooklyn, N.Y. from 1980 to 1984. From 1984 to 1995 he was a Senior Litigation Partner in a law firm. Mr. Malloy holds a B.A. from Boston College and a J.D. from Boston College School of Law.

Mr. Malloy taught undergraduate courses in political science for twelve semesters at the University of Connecticut and is now completing an appointment as Rappaport Distinguished Visiting Professor at Boston College Law School.

# 6. TEXT OF PROPOSED RESOLUTION:

That the Board of Trustees appoints Dannel P. Malloy as Chancellor for a three-year term effective July 1, 2019 at an annual salary of \$350,000.
