Trustees,

The weather is not the only sign that Fall is upon us. Students are back on our campuses for the traditional start of the academic year, and our faculty and staff are fully engaged in the fundamental work of our public mission - disseminating and building knowledge through teaching, supporting our students' learning, and research. And our public service flows from all three.

As I think about the summer break now ended, and the tradition of a Fall start to higher education's normal academic year, I can't help but observe that our need to innovate for Maine's public universities has no summer break or traditional Fall start. A culture of innovation requires that, while we remain good public stewards of the present, we always look forward, never accepting the status quo as the basis for our future viability or success.

It's a point noted in my Unified Accreditation Recommendation and report included in your September 15-16 meeting materials that were publicly released this past Friday afternoon. You've likely seen some of these materials by now, and in addition to the Unified Accreditation Recommendation you asked me to bring to prepare, along with a number of other items is a recommended change to the University of Maine School of Law's governance that we're asking you to approve so we can begin our search for the Law School's next Dean as soon as possible.

In a certain sense, matters of accreditation and governance may seem more bureaucratic than innovative. But I believe there is innovation here, and innovation ahead of us, fostered by the recommendations we're bringing to you in these matters. And if nothing else, our pace of action and leadership in Maine public higher education is picking up, and we should celebrate innovation in that too.

Considering the volume of material that's now been posted for you for next weekend's meeting in Fort Kent, I'd like to take a moment to recognize the hard work of dozens of my UMS colleagues who worked behind the scenes to prepare these materials and the recommendations in them. In doing so, I'm specifically calling out the work that went in to preparing our recommendations for the Law School and unified accreditation. There are others who won't be named here who contributed to preparing other portions of your agenda; they deserve our thanks too.
