# Bidder Questions For RFP#13-14 Elevator Maintenance and Fire Service Inspection:

## What is the anticipated start date?

University Response: July 1, 2014 is the anticipated start date, though it is subject to

change.

Please provide a copy of the sign in sheet from the pre-bid meeting.

University Response: A copy of the sign-in sheet is available upon request.

Are there any pre-existing conditions such as; outstanding code violations, shut down units, repairs, etc, that will need to be addressed by the incoming contractor?

University Response: There is one violation outstanding at Knox Hall, SWL 36447 due

to inspection failure. A replacement proposal in process. Current

status is, "out of service."

Is there any work in progress, i.e. repairs, shut downs or capital upgrades or projects, that will need to be addressed by the incoming contractor?

University Response: No. any current repairs, shut downs, capital upgrades and

projects are expected to be completed prior to the start of any

contract.

How many units on campus will require annual smoke tests? How long has the testing typically taken in past years?

University Response: Approximately 65-70 units. Each unit takes about 1 hour and

tested after scheduled work hours

Will the incoming contractor be given time to identify and correct pre-existing conditions?

University Response: Sections 8.5 and 8.8 speak to pre-existing conditions, defects and

work the Contractor believes are beyond the scope of the

contract.

Can the University provide dates for the last 5-year full load tests?

University Response: The last inspection was 2011 and all are current. They are due

again in 2016.

### Are move in/out days held during the week or over the weekends?

University Response: Move out occurs during the week. Move in occurs on the Friday,

Saturday. Sunday and Monday of the fall semester. For 2014, the

dates are August 29th-September 1st.

### Are there wiring diagrams available for all units?

University Response: Yes

Please confirm that the cost of the annual state inspections and state certificate fees will be borne by the University. (Reference "General Information", Section 1.3 par. 1 and "Scope of Service" Section 1.5.)

University Response: Section 1.3 states: Scope: The Contractor shall perform complete

inspection, preventive maintenance, incidental servicing, repair, emergency service, all parts and annual fire service inspection for the University's elevators. This does not include annual State safety

inspections and certificates, but does include tests required to pass State

safety inspections.

In accordance with Page 3, 1.8 and Page 5, 1.17, can you please provide the winning package and pricing from the previous bid. Also, can you provide a few months of recent callback data (reports), as well as the current staffing (elevator – maintenance) requirements, which may / may not be outline in the past winning bid package.

University Response: Winning RFP: Please contact the University's Office of the

President at 207-581-1517 to reach the FOAA Officer, Julie

Hopwood.

Staffing requirements: There are no minimum staffing requirements: Section 3.4 states minimum response times for breakdowns. The University expects the Contractor to maintain the safe, efficient operation of the equipment and maximize uptime. Staff and support should reflect this. As stated in Section 1.4, the overall plan and approach to maintaining the equipment listed is an evaluation criteria.

On Page 2, 1.3 & again on Page 14, 3.2.1 you have an underlined passage, which reads, "This does not include Annual safety Inspections and certificates, but does include tests required to pass State safety inspections." Can you clarify this or provide an example of how this process works. This is unique to your bid, so I would appreciate a clearer understanding of this process.

University Response.

The Contractor is not responsible to perform the annual safety inspections: This will be performed by an independent contractor retained by the University. The Contractor is responsible to maintain the elevator and perform whatever tests may be necessary so that the elevator passes the annual safety inspection and receives the certificate.

Can you please provide an excel version of the elevators / equipment list (Pages 19-22) for ease of use in providing unit pricing breakdown.

University Response: Yes, an excel version of the inventory is available upon request.

How does the University handle vandalism claims in regards to equipment malfunctions, or obsolescence in regards to equipment. (e.g. in the case of obsolescence, if a direct replacement isn't available, but a third-party modification is required to bring the equipment back to proper working order).

University Response: Claims and repairs required due to vandalism will be handled on a case-by-case basis, but required repairs would generally be considered as repairs not covered by the contract.

1.1 Scope of Service. Maintenance under this contract shall be consistently high quality to protect all elevator equipment from deterioration and to provide performance to manufacturer's specifications for all equipment.

Third-party modifications recommended by the Contractor to bring the equipment back to proper working order shall be warranted by the Contractor.

On the equipment list I understand that York and Bennett Halls were on the walk through. Are we going to get the rest of the information on the elevators where the information was left blank?

University Response: An updated list of equipment inventory will be released as

Addendum001. It contains the most current information

available to the University.
