A4. The University is not interested in packaging services but rather:

"Staff and faculty will continue to have access to the Health Clinic, but they will charged services against their insurances."

- **Q5**. Academic school year calendar dates depicting school breaks and observed holidays for 2017-2018 (looking to decipher total number of clinic days in the academic year)
- A5. Please see attached academic calendar 2017-2018.
- **Q6.** Current students residing on campus at UMFK, and if possible recent trend data.
- **A6.** Currently there are 170 students residing on campus for the 2017 spring semester. For the past three fall semesters the average number of students residing on campus has been approximately 221. The total on campus capacity for resident students is 265.
- **Q7.** Total # of clinic visits for most recent academic year and if available, historical data for 3-5 years.

- **A7**. The UMFK clinic visits for the fall 2016 totaled 326 patients seen. Please see attached for historical data.
- **Q8**. Of the Total # of clinic visits reported in Question 3, please provide detail on # of medical clinic visits and # of mental health clinic visits.
- **A8**. Total number of clinic visits reported for the fall semester was 326, of which 295 were medical clinic visits and 31 were mental health clinic visits.
- **Q9**. % of clinic utilization by students and faculty for most recent academic year, if available historical data for 3-5 years.
- **A9**. The % of clinic utilization by students and faculty is not available for the most recent academic year and historical data is not available at this time.
- **Q10**. Are vaccines included in Contractor supply costs? If so, please provide an indication of volume by providing the most recent academic year student vaccines and allergy injections provided at campus clinic, if available past 3-5 years data as well
- **A10.** The Contractor shall provide the University required immunization services and vaccinations as listed in the scope of work item #19. At this time the volume of vaccines and allergy injections is unavailable.
