#### QUESTIONS

Pricing may be provided for FTE or unit based pricing using the table labeled FTE Pricing. We encourage that you provide tiered pricing for ranges of FTEs or units. The evaluation of pricing will include total calculation (FTE Pricing x Number of Users), this will be done by the evaluation team once the submissions are received. Additionally, we would encourage similar pricing by position type (i.e. Research) using enterprise approaches. Should you use the FTE Pricing table when responding to Appendix C you will not have to include information on the other two tables in tabs 1 and 4.
