QUESTIONS

<u>Q1</u>: In order to do a complete analysis and provide you with a high-quality response, and because of the holiday season coming up and the unavailability of our technical team, would it be possible for the University to push back the submittal date by at least 3 weeks, making the new due date January 29th.

A1: OLLI is amenable to having the due date be January 29.

<u>Q2</u>: Please confirm this RFP is for the OLLI at USM only with the option for other universities and programs to opt-in to the resulting contract.

A2: OLLI is the primary focus of the RFP and resulting initial user for the registration system. The resulting Master Agreement will provide the other campuses / departments' option to use the solution if it is in their best interest throughout the term of the Master Agreement.

Q3: Is the pricing we are supposed to provide exclusively for OLLI?

A3:Yes

<u>Q4</u>: On average, how many annual registrations does the OLLI process?

A4: Pre-pandemic, around 6700 registrations annually and post around 5700. We expect those numbers to continue to grow.

<u>Q5</u>: Will the professional development program at USM use the existing solution OR should the response to the RFP ALSO include solutions for the professional development program at USM?

A5: OLLI is the primary focus of the RFP and resulting initial user for the registration system. The resulting Master Agreement will provide the other campuses / departments' option to use the solution if it is in their best interest throughout the term of the Master Agreement.

<u>Q6</u>: Please list the roles of professionals at USM who need to be included in training sessions. For example: 1 Director, 2 program managers, 1 IT professional, etc.?



A6: 1 director, 1 program coordinator, 1 administrative assistant, 2 professionals from finance, and any IT professionals specified by USM/UMS.

<u>Q7</u>: Does USM desire any in-person training?

A7: In person training is preferred, but negotiable. In the cost response make sure to denote inperson training and remote training as different options.

<u>Q8</u>: If professional development is included, please list the number of staff within professional development, the number of courses offered annually, and the approximate number of annual registrations processed by professional development.

A8: PDP is currently not part of the RFP. OLLI is the primary focus of the RFP and resulting initial user for the registration system. The resulting Master Agreement will provide the other campuses / departments' option to use the solution if it is in their best interest throughout the term of the Master Agreement.

<u>Q9</u>: Please list how many users are logging in at peak times and please list typical dates / and time of day of peak times. Please describe any scenarios USM wants to avoid and prevent, related to peak times.

<u>A9: Highest usage is the first day of fall session registration at about 1,000 logins. We want to avoid system performance issues and any effect on data retention on those busy days. We prefer to control the timing of when registrations open (rather than an automatic midnight opening.</u>

<u>Q10</u>: Please describe any scenarios you want to avoid with a TouchNet integration. Please provide at least 1 report your institution requires that is related to TouchNet and the system.

<u>Q11</u>: Please describe what USM considers to be an expedited implementation. Please explain why USM requests an expedited implementation.

A11: OLLI's current registration contract is over in June, so we need to be live by June 2024.

<u>Q12</u>: Does the OLLI use Salesforce? If not, please list the programs that use Salesforce at USM.

A12: OLLI does not currently use Salesforce. If the solution requires Salesforce additional discussions will occur with internal IT staff and salesforce post submission.

<u>Q13</u>: Does USM want respondents to include Salesforce integration as part of the pricing? If yes, please describe the flow of data with Salesforce and the new system.



A13: The potential use of Salesforce by OLLI will occur at some point in the future but is not a current need.

If the solution requires Salesforce additional discussions will occur with internal IT staff and salesforce post submission.

<u>Q14</u>: What is USM's Student Information System? Do all universities in the state have the same SIS? If not, please list. <u>A14: USM uses PeopleSoft Campus Solutions, but OLLI's registration system does not connect</u> with or use the SIS system.

Q15: What is USM's finance ERP system?

A15: PeopleSoft Financials

<u>Q16</u>: The RFP mentions Single Sign On. Please describe use case scenarios for SSO. For example, which systems and which users would be a desired fit for SSO.

A16: The use of SSO would only be for the OLLI Staff, not for students. For the few people who would be needed, it is *not* necessary and managing user accounts by the OLLI Admin is fine. Using SSO would only be useful if easy, no cost, and would allow easier user account termination.

<u>Q17</u>: Please provide 3 sample reports regularly used by OLLI

A17: Yes, see attached examples

<u>Q18</u>: What type of program registrations would the system be required to manage (please define or provide information about the type of programs and metrics required)?

A18: Membership, Courses, events, travel/day trips, and Special interest Group registrations.

Q19: What type of evaluations would UM be completing for each of the courses?

A19: A simple survey between 5 and 15 questions shared primarily with staff, who may choose to share with the instructors.

<u>Q20</u>: Other than the membership requirement, what are other types of pre-requisite requirements are required for courses or programs?

A20: Age (over 50).

<u>Q21</u>: What was the revenue for the University last year? (including credit card revenue volume and merchant statement)

A21: We are not able to address this question as part of the RFP process. The focus of the RFP is OLLI at this time.

Q22: Who is your payment processor and are you willing to change to a different provider?



A22: USM uses TouchNet; alternatives are not currently being discussed. There are additional approvals required to use solutions other than TouchNet.

Q23: Who do you use as your financial provider?

A23: Bank of America

Q24: Who is the University currently using?

Q24: Entrinsik is currently being used by OLLI

<u>Q25</u>: What data will the University be migrating to the new system?

A25: OLLI needs to migrate all contacts, their demographics, class/order history, and all previous programs/courses since 2017.

<u>Q26</u>: Is the plan to have all 6 universities using the same system (with a single database) OR for each university to have its own separate database (thus, 6 databases)?

A26: OLLI is the primary focus of the RFP and resulting initial user for the registration system. The resulting Master Agreement will provide the other campuses / departments' option to use the solution if it is in their best interest throughout the term of the Master Agreement.

<u>Q27</u>: What are total annual enrollments (distinct) across all 6 universities/10 Campuses for all nondegree professional development and OLLI courses/programs?

A27: OLLI Annual enrollments: Pre-pandemic, around 6700 registrations annually and post around 5700. We expect those numbers to continue to grow.

<u>OLLI is the primary focus of the RFP and resulting initial user for the registration system. The resulting Master Agreement will provide the other campuses / departments' option to use the solution if it is in their best interest throughout the term of the Master Agreement.</u>

<u>Q28</u>: Has budget already been allocated for this initiative? If not, when will budget be determined?

A28: Yes but it is dependent on the proposed solutions cost

Q29: When do you hope to be 'live' with a new system?

A29: June 30, 2024.

Q30: When do you plan on executing an agreement for the purchase of a new system?

A30: Yes if a solution is awarded.

Q31: What LMS do the 6 universities/10 campuses use? Is it the same for all of them?

A31: Brightspace

Q32: Do all UMS universities use Touchnet as the payment processor for online transactions?



A32: Yes

<u>Q33</u>: Does the UMS plan to share their chosen Non-Degree Registration System across all 6 universities/10 campuses?

A33: OLLI is the primary focus of the RFP and resulting initial user for the registration system. The resulting Master Agreement will provide the other campuses / departments' option to use the solution if it is in their best interest throughout the term of the Master Agreement.

<u>Q34</u>: Is the intent of this RFP to exclude non-degree program registrations outside of Professional Development & OLLI?

A34: OLLI is the primary focus of the RFP and resulting initial user for the registration system. The resulting Master Agreement will provide the other campuses / departments' option to use the solution if it is in their best interest throughout the term of the Master Agreement.

<u>Q35</u>: Will each UMS university be making their own purchase decision or should we assume the results of the RFP will be a single decision for the system?

A35: OLLI is the primary focus of the RFP and resulting initial user for the registration system. The resulting Master Agreement will provide the other campuses / departments' option to use the solution if it is in their best interest throughout the term of the Master Agreement.

<u>Q36</u>: To understand a fully implemented solution, please provide the system approach for purchase and implementation. Will there be a single implementation project for the system or is there an expectation that there will be 6 separate implementations?

A36: OLLI is the primary focus of the RFP and resulting initial user for the registration system. The resulting Master Agreement will provide the other campuses / departments' option to use the solution if it is in their best interest throughout the term of the Master Agreement.

<u>Q37</u>: Revenue is a good indicator of size. What is the annual revenue for each of the intended Professional Development and OLLI programs who "must be afforded the use of the system"?

A37: What we can provide is the registrations figures - Pre-pandemic, around 6700 registrations annually and post around 5700. We expect those numbers to continue to grow.

Q38: Will there be a single budget to fund the purchase or a separate budget per USM university?

A38: OLLI is the primary focus of the RFP and resulting initial user for the registration system. The resulting Master Agreement will provide the other campuses / departments' option to use the solution if it is in their best interest throughout the term of the Master Agreement.
